CERTIFICATE OF CONFORMITY (coll. GOST K)

To gain access to the Kazakhstan market, many goods are required to be in compliance with the criteria of the National Standards (ST RK) or safety regulations.

It mainly concerns

- Food
- Textiles, cosmetics and toys
- Electrics and electronics
- Telecom equipment
- Etc.



This conformity has to be proven by means of a Kazakhstan Certificate of Conformity.

An original or certified copy of a Kazakhstan Certificate of Conformity is required for customs clearance at the border as well as for sale/marketing within the country. For industrial equipment it is also required at commissioning.

The certified product or its packaging should be marked by the Kazakhstan Mark of Conformity.

PERMIT TO USE

In Kazakhstan many industrial equipment is subject to the approval of the Kazakh State Comittee of Industrial Development and Industrial Safety.

The Permit To Use is essential to obtain permission to put into operation such equipment as

- Lifting equipment
- Heat exchangers
- Burners and boilers
- Pressure vessels and compressors
- Etc.



A Permit To Use can only be issued on basis of an expertise executed by a Kazakh Expert Centre accredited by the Committee.



All measuring instruments imported and assumed to be applied in sphere of realization state metrological control are subject to metrological approval the Republican State Enterprise Kazakhstan Institute of Metrology (RSE KazInMetr).



Metrology Approval could be of two types either Metrology Attestation or Pattern Approval. You choose one based on your needs, terms (validy date of certificate, quantity of measuring instruments of one pattern), price, lead time, etc.
